

## Additional Resources Appendix

This Appendix includes basic information about some organizations which may be of assistance to people seeking help to solve a problem they have encountered. WCA has done its best to ensure that the information which follows is accurate and that addresses, telephone numbers, e-mail addresses, and web sites are current. However, it is quite possible that some of these have changed.

The Appendix is organized into three sections: (1) Information and Referral Services, (2) Legal Resources, and (3) Statewide/Regional Disability or Advocacy Organizations. **Unless indicated otherwise, all the organizations listed serve the entire state of Wisconsin. Many governmental and other agency resources appear in the individual chapters of this guide and therefore are not included in the Appendix.**

In addition to the resources listed here, a variety of services and supports are available to people with disabilities through various county agencies. A telephone call to the clerk of the county you live in to ask for assistance with a problem is one way to locate the part of county government which may be of specific help. Another way is to look up and call the telephone number of your local county Department of Human Services which also may be called the Department of Community Programs or the Unified Services Board.
