<b>Primary/Acute Care</b>		
BadgerCare Plus	Provides health care services to low-income adults, children and pregnant women.	815,714 total enrollees <ul style="list-style-type: none"> <li>○ 469,599 children</li> <li>○ 325,070 low-income adults</li> <li>○ 21,075 pregnant women</li> </ul>
SSI Managed Care	Provides managed primary/acute care services to individuals over 19 years old who qualify for Medicaid through an SSI disability determination.	36,300
Fee-for-Service/ Forward Health Card	In the fee-for-service delivery model, a member receives Medicaid coverage directly from the Department of Health Services. The vast majority of fee-for-service enrollees are in the Elderly, Blind and Disabled category (186,000), though some BadgerCare Plus enrollees receive fee-for-service health care instead of managed care (113,000).	299,247
<b>Adult Long Term Care</b>		
Family Care	Provides community-based managed long-term care services to older adults and people with disabilities.	44,719
Family Care Partnership	Provides community-based long-term care and medical care (primary/acute) services to people with disabilities and older adults.	3,001
Program of All-Inclusive Care for the Elderly (PACE)	PACE provides the same benefits as Partnership but is limited to frail elders over the age of 55. Members go to a physical location called a PACE Center where they receive primary care, adult day care and other medical services.	579

IRIS	Provides community-based self-directed long-term care services to older adults and people with disabilities.	12,026
Legacy Waiver (COP/CIP)	COP is a county-run long-term care program that provides services to older adults, adults/children with disabilities and individuals with significant mental illness/substance abuse needs. CIP provides long-term care services for individual diverted or re-located from nursing homes or institutions. Family Care/IRIS replace COP/CIP. Children and people with mental health needs continue to access COP in all counties.	14,675 people are enrolled in COP
Nursing Home Services	The Medicaid program reimburses nursing homes for the services they provide to Medicaid recipients. In 2015, 64% of nursing home beds were occupied by Medicaid recipients.	372 Medicaid-certified nursing homes with a total of 32,854 beds.
Institutional Services	The state operates several facilities that offer institutional long-term care for Wisconsin residents with disabilities.	484
Aging and Disability Resource Centers (ADRCs)	Local/regional ADRCs receive federal Medicaid reimbursement for the provision of information and assistance and benefits counseling related to Medicaid programs and to offset 50% of the costs of administering functional screens if those screens are used to determine an individual's eligibility for the Medicaid program.	ADRCs serve 183,192 customers.

<b>Children's Programs</b>		
Katie Beckett	A special eligibility process that allows certain children with long-term disabilities, mental illness, or complex medical needs, living at home with their families, to obtain a Wisconsin ForwardHealth Medicaid card. Children who are not eligible for other Medicaid programs because the income or assets of their parents are too high may be eligible for Medicaid through the Katie Beckett Program.	5,283
Children's Long Term Support	Serves children and individuals under the age of 22 diagnosed with a developmental disability, physical disability or severe emotional disturbance. CLTS provides services to support people in the community.	6,035 enrolled; 2,596 on a waiting list
Medicaid School-based Services	School-based services (such as occupational therapy, physical therapy, nursing services and psychological/social work services) provided to Medicaid-eligible students. In the 2016-17 school year alone, Wisconsin schools received \$187 million in Medicaid funding for school services.	120,864 students are enrolled in special education; many receive at least one school-based therapy.
Foster Care/Subsidized Adoption	Children placed in private foster care settings and children living in state foster homes are eligible for Medicaid. Children with special needs for whom adoption assistance agreements are in effect, and children adopted under state-established agreements are also eligible for Medicaid.	18,671

<b>Work Incentive</b>		
Medicaid Purchase Plan (MAPP)	MAPP aims to remove financial disincentives to work by permitting individuals with a disability who are working, or want to work, to become eligible or remain eligible for Medicaid by allowing enrollees to buy-in to Medicaid. The program also allows an individual to accumulate savings from earned income in independence accounts.	29,540
<b>Mental Health</b>		
Comprehensive Community Services	A county-option program that provides community-based psychosocial rehabilitation services for MA-eligible persons of any age to assist a person with mental illness or a substance abuse disorder to function in the community with highest possible degree of independence. One of the goals of the program is to reduce the need for institutionalized care for persons who have had episodes requiring hospitalization.	4,000
Community Support Program	All counties are required to offer (or contract for) CSP services as a more intensive form of care for adults whose mental illness and functional limitations might otherwise require them to need institutionalized care. Persons receiving CSP services generally have more acute mental illness and require support services for a longer period of time, in comparison to persons in CCS programs.	5,600
Community Recovery Services	A county-run program that offers residential-based, psychosocial rehabilitation services. This includes community living support services; self-help/peer support services; and supported employment.	236

<b>Limited Benefit Programs</b>		
SeniorCare	Helps certain low-income Wisconsin seniors purchase prescription drugs. It is partially funded with federal Medicaid matching funds.	91,717
Medicare Cost Sharing Assistance Programs	Congress has enacted several programs, collectively referred to as Medicare savings programs (MSPs), to help low-income Medicare recipients who do not qualify for full Medicaid benefits pay for Medicare's cost-sharing requirements.	21,916
Family Planning Only	This limited benefit program provides family planning services and screenings.	39,389
<b>Cancer Prevention/Treatment</b>		
Well Woman	Provides breast and cervical cancer screening and treatment services to women who don't have other insurance.	655
